July 12th, 2022

DISTRICT CHAIR, Mike Thiel, called the meeting to order at 1:32 p.m.

CONSENT CALENDAR: Regular Meeting Minutes

Minutes from the last meeting (June 14, 2022) were reviewed. We had a motion from Ben Tsang (911, STP Communications) to accept the minutes and a second from Grant Black (STP Gov). Minutes were signed. The previously accepted March 15, 2022 Minutes were also signed at this meeting.

REGULAR AGENDA:

Unfinished Business:

- 1) **ESRI Enterprise Agreement Renewal Discussion** – Traci Tracey stated the that the GIS District currently holds a Negotiated EA. Traci Tracey presented three different types of EA's available 1) Small Gov't EA 2) Public Safety EA 3) Negotiate EA. ESRI also continues to offer the Disaster Response Program - free software, access, geospatial data during an Emergency Response situation. Traci provided a brief presentation about Enterprise Agreements for the GIS District to have a better

understanding on EA's. Traci spoke about the Advantage Program which aids in training plan options and growth plans. Traci showed us a comparison of the 2019 vs. 2022 GIS District Deployment Reports. The GIS District asked about why the cost was almost 4 times higher for some with the same usage report used in 2019. There is a discrepancy in the ESRI terminology between the Deployment Reports and the GIS District understanding. The GIS District requested an audit of the Deployment Reports vs. what is actually being used by the GIS District. The GIS District requested that ESRI provide a list of all licenses deployed by the GIS District with ESRI. Traci Tracey stated this information can be located in the GIS District's myesri.com's profile.

To move forward with the EA renewal process, the ESRI reps will meet with Christine Evans to show her where she can locate all the usage information in the GIS District's myesri.com account. From there ESRI will meet with each GIS District organization to review their deployment reports and needs.

- 2) **Enterprise Agreement Participants** – Tabled for now until the EA renewal is complete.
- 3) **Waze/ Google Maps** used for Road Closures, high water, debris in roadway. – Will revisit in future meetings.
- 4) **Municipal Boundaries** – GIS District to all use the same municipal boundaries – Will revisit in future meetings.

- 5) **Voting th STPAO in the EA** – tabled for now until the EA renewal is completed.
- 6) **Sharing Agreement** - Standardize an inter-agency data sharing agreement based on all parities needs – Will revisit in future meetings.
- 7) **ESRI Rep visit** –Traci Tracey will be in town on September 7, 2022 and asked if we could move the GIS District meeting to accommodate her being in town. Motion to change the meeting to 9/7/2022 @ 1:30pm made by Christine Evans, seconded by Ben Tsang, all in favor.

Individual agency comments not made due to time of meeting running over one hour.

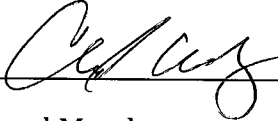
Monthly meetings will occur until the 2023 EA is finalized.
