REGULAR AGENDA:

- 1) **Library Grant Update** The STP Library has received the STP GIS District's portion of the application. The workshop the STP GIS District will contribute is in four phases.
 - I. Introduction to GIS and how it is used in everyday life
 - **II.** How to geocode addresses, specifically the STP Library Branches
 - III. How to create a Story Map of the STP Library Branches
 - **IV.** Presentation and sharing of everyone's projects

Per the grant application, the workshop will be given for two years. We are still working out the details of which branches will have the workshops and a time line.

- 2) Parish Boundary Ben Tsang met with the 911 offices of Washington and Tangipahoa Parishes to discuss 911 moving forward with Next Generation 911 (NG911). Washington and Tangipahoa Parishes use DOTD's parish boundary and STP 911 will need to adopt the boundary to ensure the boundaries snap correctly. St. Tammany Parish boundary has parcels in Washington Parish who pay STP taxes. *The next meeting, we will have a map to see the parcels in question along the Washington/St. Tammany boundary.
- 3) Unverified Addresses Notify Ben Tsang (911) of any unverified addresses that you come across that should be verified. STP GOV has noticed several addresses in MyGovernmentOnline (MPN, which is used for parish permits) that come back unverified. This will help improve the 911 addresses that we all use every day.

Ben Tsang – 911 is down to one employee and is looking to hire another person soon.
